Debriefing Note on Presentations and Discussions at 8th Caribbean Conference on National Health Financing Initiatives (CCNHFI'13) held at Hilton Rose Hall Resort and Spa, Montego Bay, Jamaica, November 12-14, 2013

- 1. Background: -- Following the decision of Heads of Caribbean Social Security Organisations (Belize City, 2005) to establish a forum for discussing approaches, challenges and lessons learnt in national health financing, the 8th Conference was convened at the Hilton Rose Hall Resort and Spa in Montego Bay from November 12-14, 2013. This followed similar meetings in Turks and Caicos Is (2006); Aruba (2007); Trinidad and Tobago (2008); St Maarten (2009); Belize (2010), Bermuda (2011) and Curacao (2012).
- 2. **Objectives:**--The overall objectives of the Conferences are to share information, increase understanding, test ideas and enhance national expertise in designing and managing national health financing initiatives. In keeping with previous conferences which selected some specific issues for deeper analysis, the 8th Conference considered Information Communications Technology (ICT), health (financing) impact of aging Caribbean populations, state of the art and opportunities in medical tourism and economic impact of chronic diseases.
- 3. Host:--The Conference was hosted by the National Health Fund (NHF) of Jamaica which was also celebrating its tenth anniversary (2003—2013).
- 4. Planning Team:--The Conference planning team included senior officials from the National Health Fund headed by Dr Cecil White (Senior Vice-President for Operations). They were supported by Dr Stanley Lalta (Conference Program Coordinator) of the HEU/Centre for Health Economics, University of the West Indies.
- 5. Participation:--The meeting attracted more than 100 full time participants from 18 countries and 27 organizations. Participants included:--

6. Programme Content:

a) Opening Ceremony—Chaired by Dr Cecil White, Senior Vice-President for Operations at the NHF, the Opening Ceremony was attended by the Honorable Minister of Health of Jamaica and Minister of Home Affairs of Anguilla. Following an invocation by Rev. Everton Jackson of the Calgary Baptist Church, participants were welcomed by Mr. Everton W. Anderson, CEO of the National Health Fund.

Ms Marisella Smith-Petronella, Manager of the Social Insurance Bank of Curacao brought remarks on behalf of the previous host and Dr Stanley Lalta provided an overview of the contents and procedures of the Conference.

Mr. Sterling Soares, Chairman of the Board of the NHF introduced the Honorable Minister of Health who delivered the feature address and formally declared the Conference open.

- ii) To consider issues related to efficiency in health systems; regional health insurance, procurement and delivery of health services; quality-based reimbursement options and design of essential health services packages in subsequent meetings;
- iii) To give more emphasis to discussions centered on 'solutions' and 'what else can be done' compared to 'issues' and 'what is the status quo';
- iv) To accept the offer of the HEU/Centre for Health Economics, UWI, Trinidad and Tobago to host the ninth Conference.
- 8. Acknowledgements:- The meeting thanked the Government of Jamaica, the National Health Fund and the various sponsors for their roles in organizing and supporting the Conference. Special tribute was paid to Dr Cecil White and the dedicated team of officers from the NHF for their professionalism as well as personal touch in handling all Conference arrangements and participants' expectations.
