Re: Debriefing Note on Presentations and Discussions at the 14th Caribbean Conference on National Health Financing Initiatives held at Royalton Antigua Resort and Spa, Antigua and Barbuda, October 19-21, 2022

1. Background

In response to requests from policymakers to 'do more for improving health systems', Heads of Caribbean Social Security Organizations at a meeting in Belize City in 2005, decided to establish a Forum—starting with a Regional Conference—for activities to build and enhance capacity in designing, implementing and effectively managing national health financing initiatives.

After the initial Conference in the Turks and Caicos Islands in 2006, discussions and activities have been continuing during follow-up Conferences in Aruba (2007); Trinidad and Tobago (2008); St. Maarten (2009); Belize (2010); Bermuda (2011); Curacao (2012); Jamaica (2013); Trinidad and Tobago (2014); Turks and Caicos Islands (2015); Bonaire (2016); Suriname (2018); and Anguilla (2019).

The 14th Conference, convened after an enforced delay due to the effects of the COVID-19 pandemic, was held at The Royalton Antigua Resort and Spa in Antigua and Barbuda from October 19-21, 2022.

2. Objectives

The overall objectives of these Conferences are to share knowledge, increase understanding, test ideas, enhance national expertise and deepen regional collaboration in designing and managing national health financing initiatives.

In keeping with previous Conferences that selected specific issues for deeper analysis, the 14th Conference focused attention on 'Confronting the Financing Challenges of COVID-19 and the Unfinished Universal Health Coverage Agenda in the Caribbean'.

3. Host

In collaboration with the coordinator, The University of the West Indies, HEU, Centre for Health Economics (UWI-HEU), the 14th Conference was hosted by the Ministry of Health, Wellness and the Environment (MOHWE) and the Medical Benefits Scheme (MBS) of Antigua and Barbuda. Further support was provided by the Pan American Health Organisation (PAHO), as well as a mix of local, regional and extra-regional sponsors.

4. Planning Team

The Conference Planning Committee included Dr. Stanley Lalta, Ms. Charmaine Metivier and other staff members from The UWI-HEU, as well as teams from the MOHWE and the MBS of Antigua and Barbuda headed by the Permanent Secretary, Ms. Ena Dalso-Henry and CEO, Mr. Kevin Silston respectively.

5. Participation

The Conference attracted around 70 full-time participants from 14 countries, as well as 10 public and private organizations. Participants included:-

- senior officers in Caribbean Social Security Organizations;
- senior managers and health practitioners from Ministries of Health;
- senior officers from national/social health financing programs;
- representatives of local and international organizations in financing, health insurance, actuarial science and health services management;
- representatives of universities, hospitals, health and IT consulting firms; and
- specially invited expert presenters.

6. Program Content

a) Formal Opening

Chaired and welcomed by Dr. Teri-Ann Joseph, Deputy Chief Medical Officer of Antigua and Barbuda, the Formal Opening featured a mix of speeches on expectations at the Conference and local cultural events. More than 110 persons comprising participants and specially invited guests from the government, public and private sectors in Antigua and Barbuda attended this event.

In addressing and opening the Conference, the Honourable Minister of Health, Wellness and the Environment of Antigua and Barbuda, Sir Molwyn Joseph highlighted how the COVID-19 pandemic severely tested the health system and affected all sectors and communities. He emphasized government's commitment to universal health coverage through transformation of the role of the MBS and strengthening primary care systems. He asked participants to optimize the learning opportunities presented by the Conference for new knowledge, ideas and capabilities to enhance the functioning of their health financing systems.

Other speakers bringing greetings from their organizations included Senator Osbert Frederick, Chairman of the MBS; Dr. Anton Cumberbatch on behalf of Dr. Althea La Foucade, Director of The UWI-HEU; Dr. Guillermo Sandoval on behalf of Dr. James Fitzgerald, Director of Health Systems and Services at PAHO; and Dr. Maglan Richardson, Acting Director of the Anguilla Social Security Board.

Dr. Stanley Lalta, Conference Program Coordinator, drew attention to the theme of the Conference—'Confronting the Financing Challenges of COVID-19 and the Unfinished Universal Health Coverage Agenda in the Caribbean'—and provided a rapid overview of the structure and content of the presentations featured in the Conference's program.

The Vote of Thanks was offered by the Permanent Secretary of the MOHWE, Ms. Ena Dalso-Henry.

Dr. Stanley Lalta, Program Coordinator, presented a review of activities and progress over the 14 Conferences (Turks and Caicos Islands, 2006; Aruba, 2007; Trinidad and Tobago, 2008; St. Maarten, 2009; Belize, 2010; Bermuda, 2011; Curacao, 2012; Jamaica, 2013; Trinidad and Tobago, 2014; Turks and Caicos Islands, 2015; Bonaire, 2016; Suriname, 2018; Anguilla, 2019; Antigua and Barbuda, 2022).

He referred to the Conferences' overall objectives as outlined by heads of Social Security Organizations in Belize in 2005 and highlighted key aspects pertaining to the level of participation; key topics covered in feature, sessional, panel and special presentations as well as issues identified by participants for further consideration.

7. Suggested Actions for the 15th Conference

The Conference recommended that actions be taken:-

- i) To give particular attention to 'Governance'; 'Public-Private Partnerships in Health'; 'Effective Health Promotion/Illness Prevention Strategies'; 'Revenue Generation Experiences with Sin Taxes'; and 'Defining Benefit Packages' in subsequent Conferences;
- ii) To specially target participation in future Conferences by representatives of national Ministries of Finance;
- iii) To prepare a list and profile of 'experts' as well as 'documents' which may be accessed by countries to assist with designing or implementing specific aspects of health financing policies;
- iv) To introduce changes in the format of presentations and discussions with some dedicated 'interactive policy dialogue and problem solving' sessions; and
- v) To accept the offer of the Fundacion Cardiovascular of Colombia (FCV) to host of the 15th Conference.

8. Acknowledgements

The Conference formally thanked the collaborating organizations—The UWI-HEU, MOHWE, MBS, as well as PAHO—for their roles and collective efforts in convening the Conference. Special thanks were also extended to the local, regional and extra-regional sponsors who provided financial, in-kind and other resources to support the Conference.
